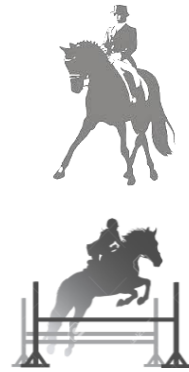

WESTERN DRESSAGE: Test of Choice (TOC)

EVENTING / COMBINED TEST: 2019 & 2018 Dressage Tests as listed on Entry Form and below.

Fees:

- Dressage or Western Dressage Test: \$30/ea
- Combined Test: \$50/ea
 - a. **Optional: one (1) Warm-Up Jumper round prior to timed round with judge.** \$20
 - b. Additional Jumper rounds after timed rounds with the judge \$20

Warm-Up and/or additional jumper rounds, please indicate on Entry Form.
The Warm Up round and additional Jumper rounds will not be judged or timed.
- Change Fee on Entry: \$10
- Competitor Entry Cancellation: (after Closing Date) No Refund
- Scratch Fee: scratches received (prior to Closing Date). Entry will be **applied to future shows** (less a \$15 office fee)
- Mini Cross Country Schooling: \$20
- Guest Horse on grounds: must have Coggins and signed SHF Release Form \$20
- Stabling (Limited stalls): \$25 one night, \$30 two nights
- Shavings: \$8 per bag
- Pasture Board: (Limited paddocks) \$15 one night, \$20 two nights
- Muck Deposit: \$40 (Separate Check)
- RV Hookup: \$35 per night
- Camp Site: \$15 per night

▶ **NCDCTA & WDAA points:** Members must include Membership #s for Horse, Rider & Owner on Entry Form.

Late Fee: Entries received **AFTER** the **SATURDAY** Closing Date will be subject to a \$30 Late Fee.

Due to the inconsistency of the USPS, Entries must be received by the Show Secretary **on or before** Closing Date.

▶ If a Competitor Scratches BEFORE *midnight prior to the* **Saturday** Closing Date, Competitor's Entry Fees will be **applied to future shows** (less a \$15 office fee).

COGGINS: Have current negative Coggins with you in your vehicle on show day and send Coggins copy with Entry. Current copies will be kept on file for the calendar year.

***COMPLETE** and send: **ENTRY**, **SHF Release Form**, **check** and **Coggins** to Steeple Hill Farm by Closing DATE.

Entries must be accompanied with payment to be processed. Entries received without payment will not be handled.

FACILITY: Dressage Ring: Tests are held in 20 x 40m or 20 x 60m (as appropriate).

- ▶ **Warm-up areas:** are separate for Dressage and Stadium Jumping.
- ▶ **Parking:** designated areas are easy pull-thru and turn around for competitors and ample parking for spectators.
- ▶ **Overnight:** stalls (limited) and camping available (reservations required): mark on Entry Form.
- ▶ **Schooling:** is available **by appointment** during the week or weekends. **Text the # below.**

OTHER INFORMATION:

- For "ADDS": Upon check-in, an open signed Check must be left with the Show Secretary. Change Fee \$10
- Current Rules: show will be held in accordance with the current rules of **USDF, USEA, USEF, and WDAA**.
- Tack and Bits: restricted to **USDF, USEA, USEF, and WDAA** Rules. (No exceptions)
- **HELMET & Medical ARMBAND:** and **ASTM** approved helmets are required when mounted.
